That's what longtime AAUW lobbyist Lisa Maatz called AAUW members during her keynote at the AAUW California Convention. I love it!!

Because we're dangerously educated, we recognize the importance of AAUW's mission to increase equity for women and girls. AAUW National CEO Kim Churches, who once again emphasized that all our activities need to be focused on the mission: "we all need to be pulling the same rope."

Here are some other convention takeaways:

- Kim has some audacious goals: train 10 million (!!) women through [AAUW's Work Smart and Smart Start](#) by 2022; and achieve pay equity by 2030. With online and in person workshops, translating materials into Spanish, and working with government and industry, we can do it!!
- The average age of AAUW membership is – wait for it – 73 years young!! We have some amazing, passionate, longstanding members, and lots of retirees who are still very active. We also need to think about what younger women need from our organization that could lead them to membership, BUT always be focusing on the mission.
- Campus Chapters. All the branches are talking about creating stronger relationships with local universities. I'm still working on this. If anyone else is interested, let's do some planning before the Fall semester.
- Tech Trek is powerful! We celebrated 20 years and 15,000 girls participating in Tech Trek! We also heard from alumni, including a rocket scientist, a civil engineer, a MD/PhD candidate microbiologist, and premed student. A few were still involved paying it forward in Tech Trek programs. Let's leverage this to engage more members of the community.
- Visibility – too many people have never heard of AAUW. The more we can do mission-based work in the community, the more we can increase our visibility.

How are you sharing the mission? Think about who you'd like to invite to an upcoming event or program. We've got a great one next month, with our State Senator Hannah-Beth Jackson as our speaker.

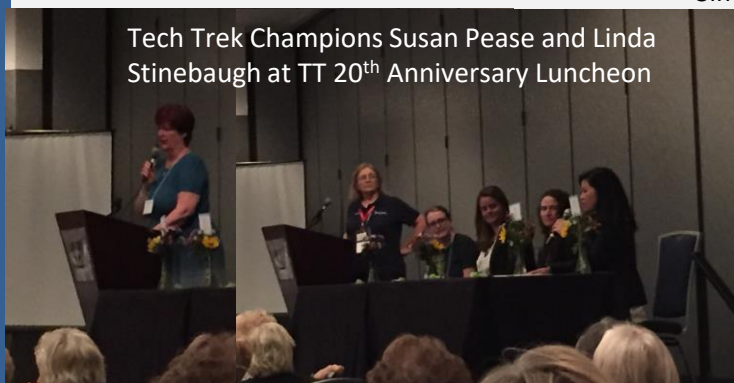

Since the Beijing Women's Conference in 1995, women have been striving for more opportunities to manage natural resources and to safeguard the environment. Today, unequal access to education and health care persists, further reducing women's agency with this issue. As a result, we've seen worsening climate pollution that disproportionately impacts women. Jan Dietrick, founder of Citizens' Climate Lobby Ventura, will speak about women in climate leadership and stewardship, the education of girls as a climate action, climate literacy, and the carbon tax policy designed to help women and other vulnerable communities.

**Jan Dietrick** was a participant at the US Preparatory Meeting (in Oakland) to the 1995 UN 4th World Conference on Women which is the inspiration for this Women's Forum. Her focus was and continues to be preventing harm from pesticide use. She has a Master's Degree in Public Health. She is a member of the Ventura County Farm Bureau and the Chamber of Commerce. She is the founding Chair of the Ventura Chapter of Citizens' Climate Lobby.

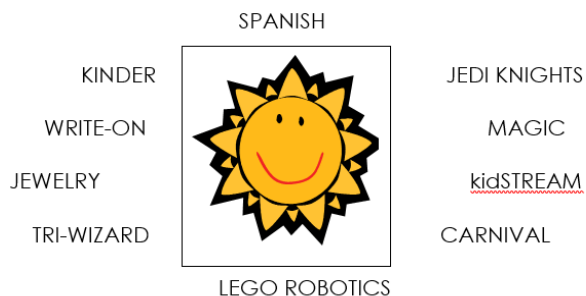

## Public Policy Matters!

### Women in the Corporate World

As the Equal Pay Month of April winds down, and in anticipation of Senator Jackson speaking to us in June, this issue of the BEACON will focus on legislation advancing the issues important to women, starting with CA SB826, introduced by Senators Jackson and Atkins. This proposal would add to the CA Corporate Code, Board of Directors, a requirement to have a minimum of one female on its Board of Directors no later than December 31, 2019. This would apply to a domestic general corporation or foreign corporation that is a publicly held corporation, whose principal executive offices are located in California. Additionally, on or before December 31, 2021, the bill would increase that required minimum number to 2 female Directors if the corporation has 5 authorized Directors, or to 3 female Directors if the corporation has 6 or more authorized Directors. SB826 also calls for the Secretary of State to publish various reports on the internet Web site documenting compliance. The Secretary of State would be authorized to impose fines for violations of the bill to offset administrative costs.

Numerous independent studies have concluded that publicly held companies perform the best in profitability, productivity, and workforce engagement when women serve on their Board of Directors. MSCI/2017 study found some 45% higher earnings per share by companies with three or more female Directors from the 5-year study period from 2011-2016. Credit Suisse/2014 found that companies with at least one woman on the Board had an average return of equity (ROE) of 12.2% compared to 10.1% for companies with no female Directors. Credit Suisse conducted a six-year global research study from 2006-2012 with more than 2,000 companies worldwide, showing improved business metrics, including stock performance; the companies tended to be somewhat risk adverse and carried less debt, on average; and reported higher net income growth.

Other countries have addressed the lack of gender diversity on corporate boards by instituting quotas, mandating 30-40% of seats to be held by women Directors. Germany is one, and Norway in 2003 mandated 40% quota for female representation. France, Spain, Iceland and the Netherlands have since followed.

Currently one-fourth of California's public companies in the Russell 3000 index have NO women on their Boards. Of the 446 publicly traded companies, representing \$5 Trillion in market capitalization, women Directors held 15.5% of seats. Only 12% have three or more female Directors on their Boards.

At this rate, achieving gender parity could take as many as 40 or 50 years! Women in leadership on Corporate Boards will boost the California economy and improve opportunities for women in the workplace. This bill is one tool to advance AAUW's goals for women in the workplace and for equity at the leadership tables of corporate America. SB826 is in committee and can be followed via the Senator's website at [sd19.senate.ca.gov](http://sd19.senate.ca.gov). The Public Policy committee will continue to track this and other bills as they advance. As always, advocacy is valuable, and you can take action by emailing your support directly to the Senator via the website or sending a letter or calling her office. As has been said, "if you don't have a seat at the table, you may be on the menu!"

## PVSD School Bond Measure

Did you know there is school bond on the ballot in the next election? Here are some reasons PVSD needs our support:

- The state of CA no longer gives money to districts for major capital improvements. We receive some, but it's less than 1% of our budget.
- The state will, however, do some limited matching of funds if they understand that the local community is committed to their schools, like passing a bond. We are counting on that for \$20-25M or so of our projects.
- PVSD is aging. Our school buildings average over 50 years old and need updated in infrastructure and layout for a more modern, collaborative classrooms
- School site parking is not designed for the drive-to-school culture of today.

Here's a partial list of about \$150M of identified projects, gathered over two years from PVSD admin, teachers, and community stakeholders:

- Classroom modernization, including classroom security upgrades, technology, furniture, wall coverings, whiteboards, flooring, windows, etc.
- Repair or replace leaky roofs
- Playground renovations, including replacement of old asphalt
- Parking lot re-design and renovation
- Replace deteriorating plumbing and sewer systems

The 1997 PVSD bond of \$49M provided renovations and improvements (in particular, AC and electrical upgrades) that are still being exploited today. This bond will be used over 8 or 10 years of building projects that should carry us forward for 25 to 30 years. Not one cent of the bond money can be used for a PVSD salary.

## AAUW National News

### **National Bylaws Amendments:**

The AAUW National Board of Directors has voted to put three proposals for bylaws amendments before the membership for a vote this spring. The board strongly supports the proposed amendments that we believe will help keep AAUW vital as an organization and enable us to increase our impact in advancing equity for women and girls.

The proposed amendments address creating three-year staggered board terms, opening board service to those outside of the AAUW membership, and eliminating the degree requirement for membership. While rationale and details for each proposed amendment can be found on the AAUW website, the overarching motivation for these changes at this time is to uphold and advance AAUW's mission and ensure optimal execution at the national board level.

The first two proposals would bring AAUW's board governance structure more in line with nationally accepted nonprofit best practices and the needs of the organization. The third proposal — to eliminate the degree requirement for membership — has come before the membership for vote a number of times. The board feels strongly that while the degree requirement made perfect sense at AAUW's inception, this requirement is now perceived by many as counter to our mission and limits our ability to build the capacity needed to increase our impact as an organization.

The board recognizes that we have not traditionally put proposals up for vote outside our AAUW National Election, but these proposed changes have been under consideration for several years by both the Governance Committee and the board, and we believe it is important to move forward without delay to position the organization for greater growth.

Voting opened on April 25, 2018, and will close June 9, 2018, at 9 p.m. ET.

We encourage you all to engage in respectful debate that has always been a hallmark of the AAUW community, exercise your vote, and encourage fellow members to do the same.

## Membership Dues Update

The AAUW National and the Camarillo Branch Boards have voted to enact the first dues change in almost a decade. Effective March 2018, annual dues for Camarillo Branch members will increase by \$15 to \$100 (National dues increase by \$10 and Branch dues increase by \$5).

Annual dues currently account for a small percent of AAUW's annual budget. The dues increase will help to sustain and grow AAUW's programs and work that advances equity for women and girls.
