A Message from Gloria Miele, Co-President

Dear Members,

Hope you are all doing well as we reach the 6-month "milestone" of this pandemic. AAUW has had a busy summer regardless and have enjoyed our Zoom time together. We miss those of you who we'd see at a meeting but are not into zooming. How can we connect?

We've had some productive board and planning meetings to get ready for the program year ahead. A few themes have emerged:

Education. As our mission is to promote education equity for women and girls through, we are continuing to support our local educational institutions through scholarships, more portable Women in History programming, and programs, like our Kick-Off on 9/13, that highlights education leaders and the current state of education in our region.

Advocacy. We are in the midst of our biggest advocacy work as we celebrate the centennial of the 19th amendment and do what we can to get out the vote in what might be the most important election of our lifetimes. AAUW has great GOTV resources - their excellent social media campaign is in the Beacon - and we are lucky to have Kathy Long leading our public policy efforts. See her excellent report inside. We also want to support our members who are running for office and hope to have a program in October to feature those who are. Diversity. For the coming program year, we are more dedicated than ever to ensuring greater diversity in our programs, membership, and activities. AAUW is an antiracist organization, and we are delighted with the interest from members and nonmembers alike in the antiracist book group, which will continue. The reality is our members are mostly older and white, so we are working hard to welcome a more diverse membership. Representation matters, so let us know your thoughts on how we can ensure our programs actively represent our community and all of Ventura County.

Note that our membership requirement of having a college degree has been challenged as a racist policy. By requiring a college degree, we eliminate women who have grown up in under resourced areas that are set up against their success. Yes, "University" is right in our name. And many members hold dear and with pride to the AAUW requirement. At this moment in time, I encourage us to reflect on the ramifications for women who may want to join but are not welcome. We may have another opportunity to vote on changing this policy to become more inclusive. More to come as national continues to make progress in this area.





Artificial Intelligence and Data

Friday, September 25th, 3:30p.m.

GoToMeeting (we are temporarily meeting online)

This is our final meeting of the year.

Policymakers in many countries are developing plans and funding research in artificial intelligence (AI). Global growth is slowing, and not surpisingly, many policymakers hope that AI will provide a magic solution. The EU, Brazil, and other Western countries have adopted regulations that grant users greater control over their data and require that firms using AI be transparent about how they use it. Will the U.S. follow suit?

Are you curious about how foreign policy takes shape? You can learn more with the AAUW Great Decisions group. Our chapter's Great Decisions meetings — the fourth Friday of each month — are informal and invite discussion. First, before the meeting, at home, we read a brief chapter in our booklet and watch a 20-minute video on the month's topic (see this year's videos here). This month's video on YouTube is entitled The Will of the People: Duterte's Philippines, and it can be found here.

On the meeting day and time, we sign into the GoToMeeting website and discuss the topic for about an hour. This is a safe, informative, and non-political venue to discuss important and current foreign policy matters. No experience is necessary!

Public Policy – AAUW Economic, Education, and Social Justice Priorities

AAUW national and local, advocates for economic security for all women; supports a strong system of high-quality education for all; and advocates to guarantee individual rights and social justice for a diverse and inclusive society. These priorities represent what we all believe necessary for a healthy democracy. Unfortunately, the public narrative for our democracy is torn apart with the current negative, angry discourse that challenges us to listen to one another and respect our differences. The racism that now is vividly shown on our national media, must be acknowledged and addressed in order to move us forward as a just and equitable society. AAUW.org statement on Racism is worth a read.

We all want healthy, safe communities. Health care is at the top of the public policy list, especially facing the unprecedented COVID pandemic. Legislatively, the Affordable Care Act put in place is a foundation for health care for all. That foundation is now being undermined and our House of Representatives Congresswoman Julia Brownley (CA-26), along with Barbara Lee (CA-13), Diana DeGette (CO-1), Jerrold Nadler (NY-10), and Chris Pappas (NH-1) led over 150 members of the U.S. House of Representatives and U.S. Senate in submitting a Congressional Amicus Brief challenging the administration's refusal of care rule. The rule, currently under consideration in the 2nd and 9th Circuit, encourages discrimination and turns away more patients, particularly women, LGBTQ+ people, and other marginalized communities, who will suffer from delays or denials in accessing health care.

The amicus brief argues that the refusal of care rule would impermissibly alter the scope of refusal statutes, overriding Congress's intent in enacting them, and that it also stands contrary to other statutes, including Title VII of the Civil Rights Act and the Emergency Medical Treatment and Labor Act (EMTALA). It also reaffirms that Congress, not HHS, is responsible for balancing competing public policy concerns.

In the spring of 2018, the current Administration issued a proposed rule entitled, "Protecting Statutory Conscience Rights in Health Care; Delegations of Authority," which drastically broadened the reach of refusal of care laws. In response, more than 100 House members sent a letter to then-Secretary Azar objecting to the rule. The refusal of care rule was finalized in May 2019 and could empower virtually anyone involved in patient care to deny medical care and information to any patient based on personal beliefs.

The rule was challenged by more than 20 states, D.C., and several other cities and localities, as well as several health clinics and providers. This led to the rule being struck down in several District Courts across the country, and their appeals have been consolidated into cases in the 9th Circuit and 2nd Circuit. We should applaud and support our representative for challenging this undermining of the Affordable Care Act, and advocate for comprehensive health care for all.

On the Economic Security priority, we know that the COVID pandemic has harmed women and people of color disproportionately by the resulting loss of economic stability nationwide. Legislation by Senator Hannah-Beth Jackson, SB 973, focused on the race and gender-based pay gap, passed off the Assembly floor on a 42 to 8 vote, passed in the Senate and is now on the Governor's desk.

Senate Bill 973 would require that California employers with 100 or more employees to submit a pay data report annually to the Department of Fair Employment and Housing, outlining compensation and hours worked of its employees by gender, race, ethnicity and job category. Employers will then be able to identify inequities in their pay and hiring practices and take action to correct them. The bill would permit state agencies to identify patterns of wage disparities and better enforce wage discrimination laws, when appropriate. It would also encourage employers to analyze and self-correct their own pay practices in the process, while ensuring privacy by requiring that individually identifiable information be protected and not available to the general public. Senator Jackson is a national leader in the fight for pay equity. She is the author of Senate Bill 358, the California Fair Pay Act, which was the strongest equal pay law for women in the country when it passed the Legislature in 2015.

As schools struggle to re-open, home school, or adopt hybrid models of education, we will all be challenged to find the path forward that will support our children. AAUW will engage in protecting our historic laws under Title IX, promote removing barriers that limit advancement of STEM fields, and not lose ground. Learn more about what's happening in our local schools at our Kick-Off meeting September 13th. We must all remain committed to that path forward. October 5th the election ballots will go out to your mailboxes –use your vote to support our AAUW priorities!
