

Second Speech Trek Contest Zooming to You Soon

With the second, annual Speech Trek Contest in progress, the participating high school students in Ventura County are impressive. They have been articulate and passionate as they address the 2022 proposition: **Has the United States lived up to its pledge of liberty and justice for all? Would requiring the study of diversity, equity, and inclusion, in a high school setting, help ensure liberty and justice for all?**"

The teen speakers have been working on researching this proposition, developing the reasons and solutions, and added their own experiences to their 5- to 6-minute speeches. Coaches Susan Seats and JoAnn Cataldo have been meeting each of the students via Zoom to assist them with the development of the research, content, and delivery of their speeches.

The semi-finals will be held on Zoom **February 23, 6:30 PM**, and the finals will take place, again on Zoom, **March 3, 6 PM**. The top three semi-finalists will receive \$200 for First place, \$150 for Second place, and \$100 for Third place. A recording of the First-place winner's speech will then be forwarded to participate in the AAUW-CA state competition that will take place during the online AAUW-CA state meeting in April. The First-place winner for the state will receive \$1,500.

Public Policy by Kathy Long

ERA UPDATE--According to Article V of the Constitution, in order to add an amendment to the Constitution, it must be passed by both houses of Congress (done in March 1972), and it is necessary that 38 of the 50 states ratify it (done as of January 2020). March 17, 2021, the House moved to enact the amendment. It now awaits the Senate. As soon as this is done, the amendment should become part of the Constitution.

Two years ago on January 27th, Virginia became the 38th state to approve the Equal Rights Amendment. The ERA Coalition, along with almost 50 other equality groups, have filed an amicus brief in the D.C. Circuit Court of Appeals case brought by the Attorneys General of Nevada, Illinois, and Virginia to force U.S. Archivist to publish the Equal Rights Amendment, being held up by the U.S. Archivist. An amicus brief is filed when it is thought that the information in the brief will be helpful to the court's interpretation. As a reminder, the Amendment states: "Section 1: Equality of rights under the law shall not be denied or abridged by the United States or by any state on account of sex. Section 2: The Congress shall have the power to enforce, by appropriate legislation, the provisions of this article. Section 3: This amendment shall take effect two years after the date of ratification." Once again, the Senate's failure to act is denying equality for all women. AAUW stands with this effort to add the ERA Amendment.

Exciting news on Broadband: California Broadband for All, signed by the Governor of California in December 2020, and set the stage for a historic policy platform. The plan brings a focus to three goal areas, speed, access and training, and affordability. In 2021, legislation passed to support broadband deployment so California can achieve the goals that will lead to digital equity and inclusion and continue the work to close the digital divide. 1 out of 8 households lack high speed internet access.

Of key interest at the state level are the following:

- •SB 156 Authorizes JPA's to issue bonds for development
- •AB 14 Internet for All Act of 2021 Prioritizes broadband for rural communities (1 out of 8 households lack high-speed internet)
- •AB 41 Broadband infrastructure Deployment to update California's "Dig Once" policies to expedite CalTrans
- ullet SB 4- The Broadband for All Act secure continuous funding and implement reforms for the CASF Program

February starts the legislative cycle for our state. We'll continue to track these bills and those put forward to improve the lives of women, children and families. In Washington, we wait for action on voting rights, Build Back Better, and some bi-partisan cooperation for the good of the country.

Update: Ventura Coast Milk Bank by Betsy Metzger

In the November Beacon, we reported on the development of the Ventura Coast Milk Bank (VCMB) to provide breast milk that helps premature infants thrive. At the time, the VCMB was recruiting local lactating donor mothers and referring them to the UC Health Milk Bank in San Diego for the donation process. The VCMB has just announced this exciting news:

"Ventura County's very first milk depot is scheduled to open in 2022 at the Ventura County Health Agency's Women, Infants, and Children (WIC)'s North Oxnard Clinic! The launch of this milk depot will allow Ventura County donors to donate milk in person, simplifying the donation process."

The donated milk is used by Neonatal Intensive Care Units in hospitals and provided by prescription to individual mothers in need.
