2024 Bylaws Changes for AAUW National

Overview and Reasons for the Proposed Amendment

The AAUW Board of Directors and Governance Committee recommend approval of the following bylaw amendment to eliminate the degree requirement for membership in AAUW. This change will align our membership practices with our purpose of advancing equity for women and girls and enable us to include members with the diverse backgrounds and perspectives needed to achieve our purpose in today's world.

We remain committed to higher education as a pathway to eliminate barriers that hold women back and to enhance their leadership opportunities at all levels. We admire the effort of the inspiring women who have led the way in earning their degrees. We recognize, however, that in today's world higher education degrees are one of several paths needed to advance equity for women and girls. Professional certifications, on the job training, career technical experience and life experience all are alternative paths to obtaining education and the skills needed to become leaders and advocates for ending discrimination against women.

When AAUW began its work, higher education and professional careers were denied to most women. That is no longer the case. More than 50% of college degrees are currently being awarded to women, and women are now attaining powerful positions in business and government. Yet discrimination against women continues. Eliminating the degree requirement enables us to expand our voice and our reach, our ability to fulfill our purpose, and will open more opportunities to address the needs of all women.

AAUW's name, which continues to have significant brand recognition for AAUW as a women's rights organization, will remain the same if the amendment is adopted.

The board recognizes that some members have strong views on the proposed change in the requirement for membership and encourages respectful debate on this important issue.

The board firmly believes that the proposed amendment is in the best interests of AAUW and its future relevance and sustainability as an inclusive and forward-thinking organization committed to advancing equity for women and girls. The board urges a vote in favor of the amendment.

Voters without a valid email address on file or who have unsubscribed to AAUW's emails will be mailed a paper ballot.

Public Policy from Kathy Long and the Public Policy Committee

STATE LEGISLATURE: A statement from Assemblymember Steve Bennett: "As respective chairs of the Water Parks and Wildlife Committee and the Budget Subcommittee No. 4 on Climate Crisis, Resources, Energy & Transportation, Assemblymember Papan and I held a joint oversight hearing on the implementation of our landmark groundwater law, Sustainable Groundwater Management Act (SGMA) resources. We heard from state departments and groundwater sustainability agency stakeholders on the progress made since SGMA passed and discussed the steps ahead of us as we try to manage our groundwater in a changing climate." As reported in prior Beacons, the Assemblymember has been leading on protecting our groundwater in our county. Although complex, important to follow and be informed on the many pieces that intersect.

AB2091: State Superintendent Tony Thurmond stood alongside Assemblymember Cecilia Aguiar-Curry, CTA, and California's teachers as a sponsor of #AB2091, the Pregnancy Leave for Educators Act. Currently, there is no paid pregnancy leave for teachers in California. This means that educators across the state must spend their sick leave to care for newborn children. This effort to establish #PregnancyLeaveNow will ensure that educators are supported to stay in the classroom while growing their families, and not penalized for it. We will track this bill.

LOCAL Reports: The Public Policy committee members recently met with Ventura County Superintendent office of Education, Dr. Cesar Morales, and his staff members. Our focus was on Title 1X and how we would assess the successful application of the law, the performance locally, and the public knowledge and engagement of parent's rights. His informed us that his office has no authority over Title 1X, it's handled by the individual school districts. He suggested we could explore the Parents Handbooks provided from the schools to begin our information gathering. Our committee will continue to explore.

We asked how the schools are performing post-pandemic: Enrollment is down, but great success with the establishment of Wellness Centers on school campuses, such as the OUHSD centers having over 17,000 self-referrals. These centers are valuable to families and students. More interaction with the County's Behavioral Health Department could be an enhancement.

Our final focus on threats of book banning were addressed with the prior action of the state's strong oversight and the threat of loss of funds; the requirement to use certain approved books; and the requirement to have a Certified Teacher Librarian to service school libraries, especially those without librarians. The Office of Education provides that position. Overall, we felt it was good first meeting. The door is open for future discussions.

Black History Month was in February, and our member and school Board Trustee Karen Sher reported on and supported a Resolution 24-07, passed by the OUHSD, Board, to support black students, calling for the practice of equity, building understanding, employing practices developmentally appropriate and to generally listen to the students. The Board committed to revisit reports thorough the year.

AAUW-CA Lobby Days are April 2-3. Their bills will be identified, and meetings held with electeds to advocate our position. We will participate and report out on the proposed bills.


