

Co-President's Message

What a year last month was. Did anyone else have that feeling about January? The relentless images of masked militarized violence, the murder of two pure hearted helpers in the streets of Minnesota, the continuous and coordinated lies by the federal government about what we could see with our own eyes. Immigration actions in Ventura County have also been relentless, and we see the chaos and fear this causes for families, especially women and children. Last month, the Executive Board approved a statement about ICE and distributed it to local media and elected officials (letter on next page). It was published on the Opinion page of the Ventura County Star on January 25th. We are proud to stand with our community and speak out for safety and civil rights.

Also in January we saw the National Park Service ordered to remove an exhibit about enslavement from the President's House at the Liberty Bell, as well as exhibits and signage describing the traumas of Native Americans, the internment of Japanese Americans, anything that is seen as "critical" of America. As an organization committed to education, the attempts to eliminate history are profoundly troubling.

And let's not forget that the DOJ is also over 40 days late in releasing the Epstein files as required by law, continuing to shield the powerful men who abused girls. I swing between exhausted to distressed to enraged. These feelings often fuel me to speak the truth. I hope you feel you can do the same. The IBC luncheon last month highlighted the current state of the First Amendment. See some important takeaways in these pages.

In all, as some smarter women than I have said, we are stronger together. We have to keep showing up for one another and our communities, with our time, talent, and treasure. We have plenty of upcoming programs and volunteer opportunities in the coming months. Join us!

Let's start by getting together in February to show each other support, to celebrate our wins and commiserate our struggles. Join us February 11th at Twisted Oak Tavern, where we will have our board meeting at 5 o'clock, then social time from 6pm on.

Statement on ICE Activity at the Local, State, and National Levels

The Camarillo, California branch of American Association of University Women (AAUW Camarillo) encompasses western Ventura County communities including Oxnard, Ventura, Ojai, and up to the Santa Barbara County line. AAUW Camarillo stands in firm opposition to the harmful and discriminatory immigration enforcement practices carried out by U.S. Immigration and Customs Enforcement (ICE). As a nonprofit committed to advancing gender equity for women and girls through research, education, and advocacy, we see the detrimental impact these actions are having across the county, specifically on women and their families. Masked agents without clear identification have violated Constitutional Rights to due process and have caused fear, disruption, and trauma across entire communities, trauma that will have longstanding consequences for all of us. ICE raids have had a chilling effect on community trust and well-being.

We call on local leaders to take immediate action:

- Prohibit the use of masked or unidentified agents.
- Enforce Constitutional rights to due process.
- Ensure that local law enforcement, in accordance with established City and County policies and the California Values Act (SB 54), will not assist with or participate in the enforcement of federal civil immigration laws.
- Take action to protect all individuals from acts of intimidation and aggression perpetrated by ICE agents.
- Demand proof that Federal ICE agents employed by the Department of Homeland Security have undergone comprehensive training in use of force and lethal weapons.

AAUW Camarillo condemns the increasingly violent and illegal actions of federal agents, and expects immediate, meaningful action from electeds and government agencies to address this national human rights crisis, from local impacts to global implications.

IBC Luncheon 2026 - The First Amendment

This year's Interbranch Council (IBC) luncheon was held on Saturday, January 24 at Los Robles Greens in Thousand Oaks. After some social time and brief updates from the Thousand Oaks, Simi Valley and Camarillo branches, a lunch buffet was enjoyed by nearly 60 guests. The program for the luncheon was an in-depth discussion by a panel of legal experts from the Colleges of Law (campuses in Ventura and Santa Barbara), moderated by Brandy Price, Dean and Chief Academic Officer of the Colleges of Law. Dean Price posed current, real-world scenarios to the panel and asked them to expound on how the First Amendment was or was not implicated. These scenarios included:

- The Columbia University ban of pro-Palestinian protestor encampments
- FCC Chair Brendan Carr's reaction to talk-show host Jimmy Kimmel's remarks about Charlie Kirk's death, resulting in a suspension by ABC
- The deplatforming or suspension of individuals on social media (e.g. "I'm in Facebook jail"), as well as pressure from the Administration on social media companies regarding content found on these platforms
- The Supreme Court upholding the law banning Tik Tok's operation in the United States unless the company gets sold to a non-Chinese owner

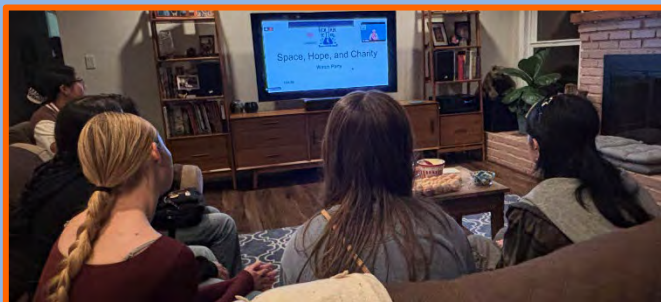
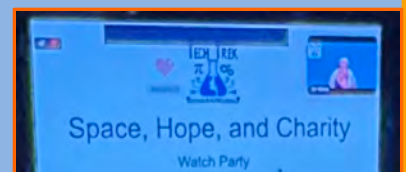
It was a powerful documentary, not just about an amazing Woman in STEM and the wonder of astronomy, but about resilience in the face of unimaginable tragedy and sadness, and the life-changing power of kindness and human connection.

After the movie, our discussion touched on Dr. Woodrum's persistence and pursuit of her PhD in Astrophysics, and her very cool work at NASA and with the James Webb Space Telescope. One alum brought up the fact that she had never heard of sneaker waves (there was a scene filmed at Moonstone Beach in California as a scientist explained it). We talked about the importance of having a strong support network like Charity had. One alum summed up the film: "sad but also uplifting." What a meaningful way to share an evening of learning, reflection and inspiration.

Public Policy by Kathy Long

AFFORDABILITY---the word of the year. What does that mean to you, to our community, to our families?

In a recent article by Jamshid Damooei, Professor and Executive Director of the Center for Economics of Social Issues for Cal Lutheran University, he details the challenges coming from the latest data from the Economic Policy Institute: In our county, a family with two adults and two children needs an annual income of \$170,791 before taxes to afford their basic needs; child care may account for 30% of their after-tax income and transportation another 15%. This data still reflects living paycheck to paycheck, and it is very challenging to make these wages in our county. Only two occupational areas –Management and Legal—historically pay an annual salary of \$160,000 or more. Buying a home here with the median price of \$965,750; monthly mortgage payments of \$6,200 is not realistic for most families. The current median family income is \$122,868. Dr. Damooei goes on to write on how we got here and what possible public policies are needed to move us to an affordable climate that provides for childcare, housing, job/career ladders and nonprofit investment. The Gender Pay Gap has been and continues to be a significant piece of the affordability puzzle for women. Despite pay discrimination being illegal for over half a century, the gender pay gap remains a glaring inequity, undermining both workers' livelihoods and the strength of our economy. In 2023, women working full-time year-round earned just 83% of the median annual salary paid to men — \$55,240 compared to \$66,790 — leaving women and their families at a persistent financial disadvantage. In 2023, women were twice as likely to work part-time than their male counterparts. When you include women who work less than 35 hours a week or in seasonal jobs in the analysis it reveals that there is not just one gender pay gap, but rather many gaps — resulting in losses in earnings, benefits, and wealth.

Mothers have 28% less lifetime earnings than women without children, and their earnings decrease by 3% with each additional child. Caregiving responsibilities and high cost of childcare, were cited as reasons for 79% of women who exited the workforce in 2021. Reduced lifetime earnings for women result in the loss of

Social Security retirement benefits, with mothers receiving 16% less retirement benefits than women without children. Info from AAUW National. Equal Pay Day March 25, 2026. Affordability is impacted by many variables.

With a final note, Ventura County Congresswoman Julia Brownley recently announced she is not running for re-election after serving the 26th District since 2012. Known for her leadership on the Veterans Affairs committee in Congress, she has championed many bills to benefit the health and well-being of our veterans. The following is from a recent report out from her District: "This year alone, my office opened 1,726 constituent cases, helping veterans and their families access health care and earned benefits, assisting small businesses in securing critical loans, and helping older Americans receive the Social Security benefits they are owed. We also helped return \$9.7 million to constituents and responded to 75,152 letters, calls, and emails from community members on issues ranging from healthcare, affordability and federal education funding, to concerns about immigration, and government accountability and transparency." We will report out as the Congresswoman wraps up 2026 this year in appreciation.
